PUBLIC PATH DIVERSION ORDER

HIGHWAYS ACT 1980

WEST BERKSHIRE DISTRICT COUNCIL (Public Bridleway Bucklebury 54a & Cold Ash 25a) Public Path Diversion Order 2025

This Order is made by West Berkshire District Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the path it is expedient that the line of the path should be diverted.

The applicant has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order, and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

BY THIS ORDER:

- 1. The public bridleway running over land at Broadview Farm in the parishes of Bucklebury and Cold Ash and shown by a bold continuous line on the map contained in this Order as described in Part 1 of the Schedule to this Order shall be stopped up on the date after confirmation of order on which the authority certifies that the works to bring the new route of the path into a fit condition for use by the public have been carried out.
- 2. Notwithstanding anything contained in paragraph 1 of this Order where, immediately before the date on which the Public Bridleway is diverted in pursuance of this Order, there is apparatus under, in, on, over, along or across that highway belonging to the statutory undertakers for the purpose of carrying on their undertaking the undertakers continue to have the same right in respect of the apparatus as they then had.
- 3. There shall from the date of confirmation of this order be a new public bridleway over land at Broadview Farm and Ramsbury Wood in the parishes of Bucklebury and Cold Ash as described in Part 2 of the Schedule and shown by a bold broken line on the map attached to this Order.

Public Bridleway Cold Ash 25a (A-W on order plan):

The full width of the public bridleway shown by a bold continuous line on the plan attached to this Order running from Point A (Grid Reference 452004 169621) in a generally north-easterly direction for 200 metres (distances approximate) to Point W (Grid Reference 452118 169780) as shown on the order plan

Public Bridleway Bucklebury 54a (W-X-Y on order plan):

The full width of the public bridleway shown by a bold continuous line on the plan attached to this Order running from Point W (Grid Reference 452118 169780) in a generally north-easterly and then north-north-westerly direction for 183 metres to Point X (Grid Reference 452162 169931) and then in a generally northerly direction for 377 metres to Point Y (Grid Reference 452222 170281) on public bridleway Bucklebury 10C as shown on the order plan

DESCRIPTION OF SITE OF NEW PATH OR WAY

Public Bridleway Cold Ash 25a (A-B-C on order plan):

A public bridleway shown by a bold broken line on the plan attached to this Order running from Point A (Grid Reference 452004 169621) in a generally east-south-easterly direction for 140 metres to Point B (Grid Reference 452133 169572) and then in a generally north-easterly direction for 117 metres to Point C (Grid Reference 452219 169649) as shown on the order plan.

Width: 4 metres

Public Bridleway Bucklebury 54a (C-1-2-3-D-E-F on order plan):

A public bridleway shown by a bold broken line on the plan attached to this Order running from Point C (Grid Reference 452219 169649) in a generally north-easterly direction through Ramsbury Wood for 263 metres to the forest track at Point 2 (Grid Reference 452421 169784) via Point 1 (Grid Reference 452308 169706), and then in a generally northerly direction through Ramsbury Wood for 197 metres to Point D (Grid Reference 452389 169958) via a culvert at point 3 (Grid Reference 452418 169900), and then in a generally northerly direction along a field edge for 73 metres to Point E (Grid Reference 452377 170029) and then in a generally north-easterly direction for 28 metres to Point F (Grid Reference 452388 170055) on public bridleway Bucklebury 10C as shown on the order plan.

Width: 3 metres between points C and D, and between points E and F. Width 3.5 metres between points D and E.
