Proposal and Statement of Reasons

WEST BERKSHIRE DISTRICT COUNCIL (OFF STREET PARKING PLACES) (CIVIL ENFORCEMENT AND CONSOLIDATION) ORDER 2009 (NEWBURY STATION CAR PARK)) (AMENDMENT NO 13) ORDER 2021

NOTICE IS HEREBY GIVEN that WEST BERKSHIRE DISTRICT COUNCIL proposes to amend THE WEST BERKSHIRE DISTRICT COUNCIL (OFF STREET PARKING PLACES) (CIVIL ENFORCEMENT AND CONSOLIDATION) ORDER 2009 (“The Principal Order”) to the extent as set out below. In all other respects the Principal Order remains in force.

It is proposed that the Order will come into operation on the [] day of [] 2021 and may be cited as **WEST BERKSHIRE DISTRICT COUNCIL (OFF STREET PARKING PLACES) (CIVIL ENFORCEMENT AND CONSOLIDATION) ORDER 2009 (NEWBURY STATION CAR PARK)) (AMENDMENT NO 13) ORDER 2021**

It is proposed to remove from the Principal Order in Schedule 1 [Pay and Display Car Park Long Stay Car Park] the Market Street Car Park which is no longer in existence

It is proposed to amend the Principal Order by adding a new car park to allow pay and display parking in the new Newbury Station Multi Storey car park as detailed in Schedule 1 of the Principal Order and to add to the Principal Order as follows:-
