NATIONAL BUS STRATEGY TARGET PROGRESS – APRIL 2022 WEST BERKSHIRE COUNCIL

The Council's Bus Service Improvement Plan (BSIP) identified a number of targets. Progress against those target is reported below. Over the last six months, work has focussed on introducing an Enhanced Partnership with the bus operators which has been successful in being awarded an indicative £2.6m from the Department for Transport for spending over the next three years.

1. Journey time and reliability

No work has yet taken place to identify appropriate journey time targets.

3. Passenger growth

The Eastern Area is composed of Purley on Thames, Tilehurst, Calcot and Theale. Estimates have been taken of passenger numbers so far, but we will obtain specific figures in the future.

To boost passenger numbers, we have run free buses in West Berkshire on the Saturdays before Christmas 2021, and again for the extended Easter weekend in 2022, including running additional buses. Similar events will be run again during 2022.
