(30MPH & 50MPH SPEED LIMIT) ORDER 202\***

**WEST BERKSHIRE DISTRICT COUNCIL** in exercise of powers under Sections 84(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following order: -

1. This Order shall come into operation on the **XX**th day of **XXXXXX** 202**[ ]** and may be cited as the **WEST BERKSHIRE DISTRICT COUNCIL (B4009 LONG LANE/SHAW HILL, SHAW-CUM-DONNINGTON, COLD ASH, CHIEVELEY & NEWBURY) (30MPH & 50MPH SPEED LIMIT) ORDER 202\***
2. No person shall drive any motor vehicle in any direction at a speed exceeding 30mph on the length of road specified in Schedule 1 to this Order
3. No person shall drive any motor vehicle in any direction at a speed exceeding 50mph on the lengths of roads specified in Schedule 2 to this Order
4. The provisions stated in Article 4 of the **WEST BERKSHIRE DISTRICT COUNCIL (VARIOUS ROADS, CHIEVELEY, COLD ASH, HERMITAGE AND SHAW-CUM-DONNINGTON) (30 MPH, 40 MPH AND 50 MPH SPEED LIMIT) ORDER 2010** are hereby revoked.
5. Nothing in Articles 2 or 3 shall apply to any vehicle on any occasion when it is being used for fire brigade, ambulance or police purposes, if the observance of that provision would be likely to hinder the use of the vehicle for the purpose of which it is being used on that occasion
6. Nothing in Article 3 shall apply to any vehicle or vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 if that vehicle or vehicles is/are being used in accordance with regulation 3(5) of those Regulations

B4009 Long Lane	Between a point approx. 637m south of its junction with Fishers Lane and a point approx. 717m north of its junction with Fishers Lane
