What data will we collect about you?

When working with you to identify and support children with Special Educational Needs, West Berkshire Council will collect the following information about you and your child:

Name and Surname

- Home address
- Age of child or young person
- · Gender of child or young person
- Ethnicity of child or young person

From schools and other alternative provision providers, the Council will collect:

- Unique pupil Number (UPN)
- Unique learner number (ULN)
- · Free school meal eligibility start and end date
- Pupil premium funding
- Service children in education indicator
- Post looked after arrangements
- · Early years pupil premium
- SEN provision
- Pupil SEN type inputted by the school of by our team following assessment

Where a child is given an SEN placement, the Council records:

- Type of setting
- · Primary reason for placement
- Date of entry into Alternative Provision
- Date of leaving Alternative Provision
- Association other non-education services supporting the pupil
- Attendance pattern full or part time
- · Sessions per week
- Previous school attended

What will we use your data for?

Your data is essential for maintaining the education and social care services that are provided. The council has a statutory duty to monitor placements and in many cases also financial responsibility.

The data we collect from the sources listed above are provided to the Department for Education (DfE) as part of a yearly "Alternative Provision Census".

Who will see your data?

You data will be seen by members of West Berkshire Council's Special Educational Needs Team.

We may also make some information available to other professionals directly involved with the services we provide you, such as, heath partners, school employees and social care

colleagues. Data will also be shared with members of the SEN panel to enable them to advise and assist in decision making.

Data will be provided to the Department for Education as part of the Alternative Provision Census using COLLECT, a centralised data collection and management system run by the government. Why are we doing this?

We are legally processing your data under the requirements of the Education (Information about Children in Alternative Provision) (England) Regulations 2007 by submitting the Alternative Provision census, which includes a named set of pupil records. The Council is required to do this by law. There's more on your rights below (see "Your Rights").

How long will your data will be kept?

Your data will not be kept any longer than necessary. You can check how long the organisation will keep each type of data against West Berkshire Council's retention schedule (www.westberks.gov.uk/retention).

How is your data stored and processed?

Your data will be held on the Council's database designed for education information, called CapitaONE. Your data is protected using up-to-date technical and organisational security measures.

Transfer overseas

Your data will not be stored or sent outside of the UK.

Your rights

You have a number of rights when it comes to the data we hold about you. These are detailed on our request form (www.westberks.gov.uk/dprequest) that also allows you to make a request for us to take action about something.

Complaints
